is the past Chair of the Life Safety Correlating Committee, and chairs the NFPA Life Safety Technical Committee on Health Care Occupancies.


Kelly Mason Director of Healthcare Partnerships

Executive Director of ASHE, Director of Planning, Design and Construction for the AHA, and the Director of Engineering for the Joint Commission in Chicago, IL. Doug was also selected for ASHE's highest membership award in 2013 – The Crystal Eagle.
